Dear Carson City Voters,

AB 126 during the 2021 Legislative Session resulted in the creation of the **Nevada Presidential Preference Primary (PPP)** elections. All **active** registered voters will receive a mail-in ballot unless they have opted out of receiving one. There will be early voting for one (1) week from Saturday, January 27, through Friday, February 2, and Election Day, Tuesday, February 6 at the Carson City Community Center.

Nevada voters who are registered as a Democrat or Republican can vote in Nevada's PPP. **Non-Partisan or other affiliated parties will NOT receive a mail-in ballot.** Anyone can change their party affiliation at RegisterToVote.NV.gov or during Early Voting and on Election Day at the Community Center. Save time and check your registration status to save time at the polling location.

### **Do the PPP winners automatically get on the General Election ballot?**

The results of the PPP are nonbinding and merely give the state Democratic and Republican parties guidance on how their voters would like their delegates to vote at the state and national conventions.

Regardless, whichever candidate gets the most delegate votes at their party's respective state convention then gets placed on the November ballot.

AB 321, 81st Legislative Session (Nev. 2021), enacts provisions mandating this office to mail all **active registered** voters a mail ballot. You may choose to vote your mail ballot or to vote in-person using a voting machine.

If you choose to vote in-person, please appear at the polling location during Early Voting or Election Day polling hours. You may surrender your mail ballot or sign an affirmation surrendering your mail ballot before being issued a new ballot to vote in-person using a voting machine.

# FREQUENTLY ASKED QUESTIONS

**WARNING: “A person who is entitled to vote shall not vote or attempt to vote more than once in the same election. Any person who votes or attempts to vote twice at the same election is guilty of a Category D felony and shall be punished as provided in NRS 193.130.” (NRS 293.780(1)).**

**Do NOT vote in person AND mail in your ballot!**

## **HOW DO I VOTE IN PERSON?**

There will be **one** polling location for **in-person** voting during Early Voting and on Election Day:

CARSON CITY COMMUNITY CENTER GYMNASIUM  
851 E. William Street

THE DESIGNATED POLLING LOCATION ENTRANCE WILL BE AT THE MAIN GYMNASIUM ENTRANCE ON THE EAST SIDE OF THE BUILDING.

**\*\*NOTE: THE CARSON CITY COURTHOUSE IS NOT AN IN-PERSON POLLING LOCATION FOR THIS ELECTION**

Jump Around Carson (JAC) will be offering free rides to and from the Community Center polling location on **Election Day**.

## **WHAT IMPORTANT DEADLINES ARE APPROACHING?**

**Active Registered Voters with the Democratic and Republican parties who have not opted out of receiving a mail ballot can expect their ballot to be mailed no later than January 15, 2024.**

**NOTE: You will NOT be mailed a ballot if you are not affiliated with either the Democratic OR Republican political parties.**

- **January 9, 2024**

- Close of voter registration by personal appearance (the 4<sup>th</sup> Tuesday preceding any election).
  - Last day a person may register to vote by appearing in person at the Carson City Elections Office (NRS 293.560(1)(a)(1))
- Close of Voter Registration by mail (the 4<sup>th</sup> Tuesday preceding any election). Last day a person may register to vote by mail (must be postmarked by this date) NRS 293.560

- **January 10, 2024, through February 6, 2024**

- Updating voter registration information online.
  - After the close of registration for an election, a registered voter may update their voter registration information online through the Nevada Secretary of State – [www.RegisterToVote.NV.gov](http://www.RegisterToVote.NV.gov)

- **January 24, 2024, through February 6, 2024**

- Extended online voter registration.
  - During this time, online registrants updating their registration or registering must appear at the polling location during Early Voting or on Election Day with proper identification and proof of residency.

- **January 27, 2024, through February 2, 2024**

- Early Voting period for in-person voting at the Carson City Community Center.

- **Tuesday, February 6, 2024**

- Presidential Preference Primary Election Day for in-person voting at the Carson City Community Center.

- **Saturday, February 10, 2024 @ 5:00 p.m.**

- Deadline for all ballots postmarked on or before February 6, 2024, to be counted on this date.

- **Monday, February 12, 2024 @ 5:00 p.m.**

- Last day for curing of mail in ballots to be counted for the election.

- **Friday, February 16, 2024 @ 8:30 a.m.**

- Carson City Board of Supervisors canvasses the vote.

## **WHAT WILL BE ON MY PRESIDENTIAL PREFERENCE PRIMARY BALLOT?**

- This *Voter Information and Sample Ballot* includes **ALL** candidates, for both the Democratic and Republican parties, on the Presidential Preference Primary ballot as filed with the Secretary of State's Office. The ballot styles by party are in alphabetical order after the Frequently Asked Questions. Please verify your party affiliation to make sure you obtain the correct ballot style by party before you appear to vote.
- You can check and update your voter registration information at the Nevada Secretary of State's website [RegisterToVote.NV.gov](https://RegisterToVote.NV.gov).
- You can also change your Party affiliation during early voting or on Election Day, but expect long lines for this process. You will be required to provide proof of identity to update your voter registration status.

## **WHAT IS NEVADA EASE VOTING?**

- EASE (Nevada's Effective Absentee System for Elections) is an online application that seamlessly integrates voter registration and electronic ballot delivery and marking. EASE allows further independence and enables covered voters (Active-Duty Military, Voters with a Disability, or Tribal Voters who live on a colony or reservation) to register, request, mark and return their ballots. EASE is available for elections with a federal contest on the ballot 45 days before Election Day at [www.NVEASE.gov](https://www.NVEASE.gov). The Nevada Secretary of State plans to activate the website on December 23, 2023.

## HOW DO I VOTE MY MAIL BALLOT?

- **By mail:**
  - Mark your ballot (**instructions will be provided with your ballot**).
  - Sign the return envelope (for verification purposes) and return your ballot in the postage-paid envelope provided. Make sure the envelope is postmarked on or before Tuesday, February 6, 2024.
  - Mail ballots postmarked on or before February 6, 2024, that are received by the Clerk's Office no later than the fourth day after the election—Saturday, February 10 — will be accepted in the election.
- **In-person delivery:**
  - **BALLOT DROP BOX:** Mail ballots being delivered in-person at an official ballot drop box must be received by the Clerk's Office no later than 7:00 p.m., Tuesday, February 6, 2024.

## WHERE ARE THE OFFICIAL BALLOT DROP BOX LOCATIONS?

- A nonpartisan team of election workers is responsible to monitor and assist voters with their mail-in ballot. ONLY mint-colored Carson City Ballot envelopes are accepted in the ballot drop locations. Other county ballot envelopes must be taken to those counties.
- **Carson City Senior Center (East Entrance), 911 Beverly Drive**
  - Saturday, January 27, from 10 a.m. to 2 p.m. and
  - Election Day, February 6, 2024, from 7 a.m. to 7 p.m.
- **Carson City Community Center, 851 E. William Street**
  - Early Voting, Saturday, January 27, through Friday, February 2, 2024
  - Election Day, Tuesday, February 6, 2024, from 7 a.m. to 7 p.m.
- **Carson City Elections Office at the Courthouse, 855 E. Musser Street, Suite 1025**
  - **Open during Early Voting and Election Day polling hours, and regular business hours prior to Early Voting and Election Day (8 a.m. – 5 p.m.).**

## **WHAT IF MY SIGNATURE HAS CHANGED OR DOES NOT MATCH?**

- The Clerk's office will send a letter with instructions on how to cure your signature. We may contact you via phone or email, if provided, at the time of registration.
- **The deadline to cure the signature discrepancy is no later than 5:00 p.m., Monday, February 12, 2024. Once cured, the voter will have their ballot counted.**

## **WHAT IF I AM UNABLE TO VOTE AND/OR SIGN MY MAIL BALLOT DUE TO A LIMITING CONDITION?**

- The Nevada Secretary of State's Office has a web-based solution if you are unable to sign your mail ballot. Please visit [www.NVEASE.gov](http://www.NVEASE.gov) to find out more.

## **WHAT IF MY MAIL BALLOT ENVELOPE STATES "ID REQUIRED"?**

- If you registered to vote by mail or did not provide proof of identity at the time of registering, you may be required to provide proof of identity and residency with your ballot. Please contact the Clerk's Office at (775) 887-2087 with any questions.

## **HOW DO I KNOW IF MY BALLOT WAS RECEIVED BY THE CLERK'S OFFICE?**

- The Clerk's Office will post a list of mail ballots received in alphabetical order on its website: [carson.org/elections](http://carson.org/elections).
- You may contact the Clerk's Office directly at (775) 887-2087.

## **WHAT IF I NEED TO MAKE A CORRECTION ON MY MAIL BALLOT SELECTIONS?**

- You will receive instructions in your mail ballot packet explaining the process for making a correction on your ballot. Please read the instructions prior to making a correction. If you need further assistance, please contact the Clerk's Office prior to making a correction.

## **DO I NEED TO PUT POSTAGE ON MY MAIL BALLOT TO RETURN IT TO THE CLERK'S OFFICE?**

- Mail ballot **postage is pre-paid**. You do not need to put additional postage on your mail ballot return envelope.



## **HOW DO I VOTE IN PERSON USING A BALLOT MARKING DEVICE?**

- **INSERT** paper ballot into Expressvote ballot marking device.
- **MAKE YOUR SELECTIONS** on the Expressvote touchscreen.
- **VERIFY YOUR SELECTIONS** on the Expressvote touchscreen.
- **MAKE YOUR CORRECTIONS (if needed)** on the Expressvote touchscreen.
- **PRINT YOUR SELECTIONS** from the Expressvote ballot marking device.
- **REVIEW** your printed selections on the paper ballot.
- **CAST YOUR BALLOT** by placing your printed paper ballot in the polling location tabulator as you exit the polling location.
- **If you need assistance, please notify an election worker BEFORE you cast your ballot. Once your ballot is cast, it cannot be retrieved.**
